BREAD & BROTH (B&B) VOLUNTEER AGREEMENT AND RELEASE

I understand and acknowledge that signing this Volunteer Agreement and Release constitutes an agreement to all of the following provisions concerning my participation in the Bread & Broth volunteer activity:

I understand and acknowledge that my time and services as a volunteer are being donated by me without contemplation of compensation or future employment, and that I provide these services for charitable and humanitarian reasons.

I understand that as a volunteer I will earn no wages or benefits in connection with the volunteer services I wish to provide, and that I will not seek any such wages or benefits. I further understand that I will not be entitled to unemployment insurance benefits upon the discontinuance of my volunteer services nor will I be covered under any workers' compensation insurance in the event I am injured while engaging in the volunteer services I will provide.

In signing this Release, I acknowledge and understand that, during my participation in a volunteer activity for B&B, I may be exposed to a variety of hazards and risks, foreseen and unforeseen, which are inherent in such volunteer activities. These inherent risks include, but are not limited to, the dangers of serious personal injury, property damage, and death. I acknowledge that B&B has not tried to contradict or minimize my understanding of these risks. I know that injuries and damages can occur by natural causes or activities of other persons, either as a result of accidents, negligence or because of other reasons. I will exercise extra care for my own person and for others around me in the face of such hazards. I further understand that during a volunteer activity for B&B, there may not be rescue or medical facilities nearby or expertise necessary to deal with the injuries and damages for which I may be exposed.

I KNOWINGLY AND VOLUNTARILY PARTICIPATE IN THESE ACTIVITIES WITH KNOWLEDGE OF THE RISKS AND HAZARDS INVOLVED, AND I AGREE TO ABIDE BY ALL BREAD & BROTH RULES AND REGULATIONS.

In consideration for my acceptance as a participant in this volunteer activity on behalf of B&B, I, and my heirs, administrators, guardians and legal representatives hereby release, waive, hold harmless, and forever discharge the Roman Catholic Bishop of Sacramento, a corporation sole in trust for the pastor of St. Theresa Parish, South Lake Tahoe and Lake Tahoe Community Presbyterian Church from any and all losses, injuries, damages, claims, demands, actions, and causes of action of any sort, including but not limited to injury to my person or property arising out of or in connection with my participation in the B&B volunteer activity.

Furthermore, I hereby grant Bread & Broth permission to use my likeness in photograph, video or other digital media (photos) in any and all publications, including web-based publications, without payment or other consideration. I understand that all photos are the property of B&B and can be edited, copied, exhibited, published or distributed for lawful purposes. I waive the right to inspect or approve the photos with my likeness. Additionally, I waive the right to any royalties or other compensation related to the use of the photos for myself, my heirs, or any other person acting on my behalf.
